# INSTRUCTIONS / WARNINGS BUCKINGHAM MODEL 5203 SERIES HARNESS BEAMS

Warning: Do not use this product if you cannot understand and follow the instructions and warnings that come with it and complete all necessary functions.

The harness beam is designed to be used by electric utilities and training facilities for the training of apprentice **linemen**. It is designed to fit over the top of the utility pole and to be secured in place by the eight leveling footpads / bolts. Additionally, the harness beam provides a support structure for a fall arrest system including, a rated anchor point for a retractable lifeline in compliance with regulatory standards. The snaphook of the retractable lifeline is to be connected to the dorsal attachment of a fall arrest harness being worn by the user. If the user were to experience a gaff "cut out", the retractable lifeline would engage and arrest the fall, preventing the user from falling to the ground. The device allows rotation of a lifeline 360° around the utility pole with little effort and is easily installed and removed from a utility pole without extensive setup.

Selection of products should be such that they aid the worker in the performance of his job and particular work situation. Therefore, be certain this equipment is suitable for the intended use and work environment. It should only be used as personal protection equipment. If suitability for intended use is questionable, always consult your Supervisor, Safety Director or contact Buckingham Mfg. at (607) 773-2400 or 1-800-937-2825.

# INSTALLATION GUIDELINES

- 1. This unit will accommodate 9.5" diameter poles. Larger diameter poles must be shaved to meet this requirement. NOTE: A 45 ft. class 3 pole should accommodate the 5203 Harness Beam without shaving the pole top. Buckingham Manufacturing recommends using the 5203-12 Harness Beam for pole diameters larger than 9.5" and up to 12".
- 2. The eight threaded anchor pins (4 top, 4 bottom) must be backed out such that the unit will slide over the pole top.
- 3. The Harness Beams weigh approximately 160 lbs. Rigging, winch lines, booms and all lifting equipment must have appropriate capacities.
- 4. To attach the Harness Beam to the pole top:
  - Connect the winch line to the Harness Beam using the lift eye provided at the top of the unit. NOTE: Do not attempt to install this unit on the pole with the retractable lifeline already attached to the arm.
  - Lower the Harness Beam onto the top of the pole until it bottoms out.
  - Level the Harness Beam. Set a level on the flat area just below the arm
    (level sitting left to right as installer is facing unit) and check. Level in a second
    direction with the level located 90° from its first position. When level, tighten the
    eight (8) anchor pins. Move the level to it's original position and recheck. If not level,
    the installer must loosen anchor pins, reposition the unit to level and retighten the
    anchor pins.



- 5. Connect the locking carabiner attached to the anchor mounting bracket of the Retractable Lifeline to the attachment hole of the Harness Beam arm. Also, tie a tag line to the Retractable Lifeline snap hook and pull the lifeline down as needed from ground level and to control the speed of retraction upward into the housing.

# **Inspection Procedure**

- 1. Inspect the complete Harness Beam assembly frequently and at regular intervals.
- 2. Inspection should include but not be limited to those areas shown in the illustration below.
- 3. The entire unit should be inspected for:
  - a. visible cracking
  - b. corrosion
  - c. excessive wear
  - d. distortion
  - e. any other visible damage
- 4. Check the six cap screws on the top of the unit (surrounding the eye bolt) for tightness.
- 5. Check arms for ease of movement. Arms should rotate around the center post smoothly and easily with no binding.
- 6. Check arms for excessive vertical movement. Movement in this direction could mean worn bearings or insufficient tightness of the cap screws.
- 7. All welds must be inspected for visible cracks or breaks.
- 8. Ensure all anchor pins and leveling footpads turn smoothly and are not rusted. If the Harness Beam is installed on the pole, check that all anchor pins and leveling footpads are present and have not loosened. If any of the anchor pins have loosened, retighten the loose pin(s) and recheck that the Harness Beam is level. Lubricate anchor pins and leveling footpads as often as required to maintain smooth operation (no binding) with light weight lubricant such as WD-40°.

- DO NOT install the Harness Beam on or near a utility pole that contains live power wires.
- Never install the Harness Beam on a cracked or damaged utility pole.
- The Harness Beam will function best on a utility pole that is plum.
- This equipment must only be used for personal use only, not for hoisting.
- Only Buckingham Mfg. Co. or those people authorized in writing by Buckingham Mfg. Co. may make repairs / modifications to this equipment.
- Never work without independent fall arrest protection if there is danger of a fall.
- Attach only compatibly sized snap hook onto rear fall arrest D-ring on harness and fall arrest anchor
  point. In the absence of a compatibly sized connector, use a locking type connector designed for the
  intended application.
- Always visually check that each snap hook / carabiner freely engages D-ring or anchor point and keeper / gate is completely closed with each use. **Never** rely solely on the feel or sound of a snap hook / carabiner engaging.
- Make sure each snap hook / carabiner is positioned so that its keeper / gate is never load bearing.
- Ensure there is no pressure on the snap hook locking mechanism sufficient to depress it as this will, due to its length, render it incompatible with currently designed rings and make it very susceptible to rollout.
- Never disable locking keeper / gate on snap hook / carabiner, punch holes in or alter a connecting device in any way.
- Always keep anchor point above rear fall arrest attachment. Never climb above the anchor point of the harness Beam.
- Never attach more than one Retractable Lifeline or user to an attachment hole of a Harness Beam arm.
- Ensure the line of the Retractable Lifeline attached to the harness beam does not become tangled or hung up on the pole during maneuvering about the pole while climbing or performing other operations.
- Product covered under these instructions / warnings should not be resold / redistributed or re-used after use by original user.

#### STATEMENT of OBSOLESCENCE:

Precise "useful life expectancy" or "shelf life" for this product is not specified, as the degree of use, conditions of use, and the degree of care and storage determines useful life.
